I began the process of centralizing management of reception, clerical support, medical records, and clinical documentation auditing that had been performed at each clinic site. Policy, standards and training were inconsistent. I began regular support staff meetings and collectively identified service delivery problems. (I completed the process of integrating all support services centrally after promotion to Administrator). In 1993, I was assigned the administrative lead in

implementing the System of Care model, which began the movement of clinical service provision from clinic based offices to a community base, in schools, at home and at other agency locations. Beginning with a federal grant, I implemented a treatment program utilizing volunteer, student intern and agency personnel. I began therapy and educational programs for inmates and their families that emphasized practical skills development such as perception, communication and job readiness. Reading program sessions were videotaped showing one inmate learning how to read, going from a first grade to a sixth grade level. A follow up study showed one of the lowest recidivism rates in the state. Within three years it was chosen by the California Department of Alcohol and Drug Programs as 1 of 3 to represent California as models for the nation.
